A final list (including pricing) will be due April 1, 2019 and must be provided on this form. **The approved price listed on this form is to be the same throughout the duration of the fair.** After April 1, 2019 any additions, changes or deletions need to be made in writing to the Rental Office. No additions, changes or deletions can be made after the Ohio State Fair begins. Inspections will be performed during the fair to ensure that only the approved items are being sold. If non-approved items are discovered, they must be pulled immediately.
